A limited number of these Bursaries are open to full-time students of merit who have graduated from a Brant County Secondary School or are an immediate family member (child or grandchild) of a Brant Rod & Gun Club member enrolled in a program in Forestry Management, Biology, and areas of Contemporary Studies or Environmental Studies.

These Bursaries are valued at \$1000 each.

To apply for a Brant Rod & Gun Club Bursary Award a student must;

- be enrolled in full-time studies in a community college or university;
- have demonstrated financial need;
- exhibit academic proficiency;
- have or are making a difference in the City of Brantford or the County of Brant through volunteerism, community work or other leadership roles.
